The Court conducted a conference/hearing with counsel for the parties on May 4, 2020. Thereafter, James filed a Reply to Investacorp's Verified Opposition (Doc. 8) on May 5, 2020.

5.

The Temporary Restraining Order remains in place at this time.

6.

The parties have reached a settlement and, with the consent of Investacorp, James seeks to dismiss his Complaint, with prejudice. As a result, it is also appropriate for the Court to dissolve the Temporary Restraining Order.

WHEREFORE, Plaintiff Ian James moves the Court to enter an Order dismissing his Complaint and claims against Investacorp, Inc. in this matter, with prejudice, and to dissolve the Temporary Restraining Order.
