In addition, when you appeal an Exam Waiver denial from FINRA it comes to the NAC, as does a Membership appeal.

Where can we as Small Firm members do something about the way FINRA administers the rules? On the NAC, that's where. I have been, and will continue to be, your outspoken and unrelenting voice fighting for significant regulatory relief and serious recognition of our Small Firm community as the incredible and irreplaceable asset of the investing public.
